**RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR PROVIDING
TRAFFIC ENGINEERING CONSULTING SERVICES FOR THE COUNTY OF SALEM,
RFP #25-02 RESUBMISSION**

WHEREAS, the Salem County Purchasing Office properly advertised seeking "fair and open" proposals for the provision of traffic engineering consulting services for the County of Salem in accordance with N.J.S.A. 19:44A-20.4 et seq.; and

WHEREAS, sealed proposals were received and read for furnishing and delivering the aforesaid services in accordance with N.J.S.A. 19:44A-20.4 et seq. and in accordance with the Brook's Act (commonly referred to as a "two-envelope" solicitation) as follows:

Pennoni Associates Inc. Haddon Heights, NJ

WHEREAS, it has been determined that **Pennoni Associates Inc.**, Haddon Heights, NJ is qualified to provide the aforesaid services of the type and nature required; and

WHEREAS, the separate cost proposal for the provision of these services is \$27,611.00.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Board of County Commissioners of the County of Salem awards a contract for the provision of traffic engineering consulting services for the County of Salem, subject to the approval of the County Solicitor, to **Pennoni Associates Inc.** in the amount not to exceed \$27,611.00 (Twenty-Seven Thousand Six Hundred Eleven Dollars and Zero Cents).
2. The contract commencing, May 22, 2025 and continuing until June 30, 2025. This is contingent upon appropriation of sufficient funds that ends on the same date. Should any grant funding be extended, this contract may similarly be extended but shall not cumulatively exceed twelve (12) consecutive months.
3. The County Commissioners Director and the Clerk of the Board shall be authorized to execute said contracts.


