RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES CONTRACT FOR FINAL DESIGN FOR WELCHVILLE ROAD, COUNTY ROAD #540 RESURFACING AND SAFETY IMPROVEMENTS FOR THE COUNTY OF SALEM

WHEREAS, the County of Salem seeks to secure the services of a Firm to perform Final Design for Welchville Road, County Road #540 Resurfacing and Safety Improvements Project (from NJ Route #45, MP 8.70 to the Railroad Tracks, MP 11.67, a distance of 2.97 miles) for the County of Salem; and

WHEREAS, the Salem County Purchasing Office properly advertised seeking "fair and open" proposals for the Final Design for Welchville Road, County Road #540 Resurfacing and Safety Improvements Project (from NJ Route #45, MP 8.70 to the Railroad Tracks, MP 11.67, a distance of 2.97 miles) for the County of Salem; and

WHEREAS, four (4) qualified Firms responded to the "Request for Proposal and Qualifications" on July 15, 2025 at 11:00 am as follows:

"Consulting Engineer Services"	Sicklerville, New Jersey
"Taylor Wiseman & Taylor"	Mount Laurel, New Jersey
"French & Parrello Associates"	Wall, New Jersey
"Environmental Resolutions, Inc."	Mount Laurel, New Jersey; and

WHEREAS, the Salem County Board of County Commissioners have determined that a need exists for the aforementioned Professional Services; and

WHEREAS, an evaluation of the Proposals based on the criteria outlined in the "Request for Proposals" resulted in "**ENVIRONMENTAL RESOLUTIONS, INC.**" of Mount Laurel, New Jersey receiving the recommendation of Award of Proposal from the "Review Committee"; and

WHEREAS, the "Request for Proposal and Qualifications" was solicited through a "Fair and Open" process, in accordance with N.J.S.A. 19:44A-20.4 et seq.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. A Professional Services Contract be issued to "**ENVIRONMENTAL RESOLUTIONS, INC.**" in accordance with their Proposal for "Final Design for Welchville Road, County Road #540 Resurfacing and Safety Improvements Project (from NJ Route #45, MP 8.70 to the Railroad Tracks, MP 11.67, a distance of 2.97 miles) for the County of Salem" for their Total Amount of **\$74,290.00** (Seventy-Four Thousand, Two Hundred Ninety Dollars and Zero Cents).
2. The Director and Clerk of the Salem County Board of County Commissioners are hereby authorized to execute the Contract for "Professional Services" subject to the approval of the County Solicitor.
3. A "Notice of Award" of said Professional Services Contract shall be published as required by law.


