WHEREAS, the Purchasing Agent has reported Paving Plus LLC. was the lowest responsive, responsible bidder; and

WHEREAS, it was determined the company Paving Plus LLC substantially met the necessary qualifications for the fulfillment of the contract and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents shall become a part of the contract; and

WHEREAS, the contract will commence on October 15, 2025, through December 31, 2025, with the same terms and conditions as outlined in the Bid specifications and proposal.

WHEREAS, the maximum contract amount is \$288,000.00

- 1. The Salem County Board of County Commissioners hereby awards a contract for Repairs to Roads in Oldmans Township in the County of Salem, subject to the review of the County Solicitor, to Paving Plus LLC, the cost of which will not exceed \$288,000.00 (Two Hundred Eighty-Eight Thousand and Zero Cents) for the duration of the contract.
- 2. The contract shall commence on October 15, 2025, and terminate on December 31, 2025. This shall be completed in full accordance with the terms and conditions of the contract.
- 3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
