

**RESOLUTION AWARDING A CONTRACT FOR VARIOUS DRAIN PIPE REPAIRS
THROUGHOUT OLDMANS TOWNSHIP IN THE COUNTY OF SALEM**

WHEREAS, the Salem County Purchasing Agent, as authorized contracting Agent for the Board of County Commissioners of the County of Salem requested, received, and opened sealed proposals on October 2, 2025, at 11:00 AM prevailing time for Repairs to Drain Pipes in Oldmans Township in the County of Salem. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, bids were received as follows:

Landberg Construction	Dorothy, NJ	\$194,350.00
R.E. Pierson Construction	Woodstown, NJ	\$259,244.31
South State, Inc.	Bridgeton, NJ	\$182,000.00

WHEREAS, all bid results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400, in the County of Salem New Jersey as required by law; and

WHEREAS, the Purchasing Agent has reported South State Inc. was the lowest responsive, responsible bidder; and

WHEREAS, it was determined the company South State Inc. substantially met the necessary qualifications for the fulfillment of the contract and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents shall become a part of the contract; and

WHEREAS, the contract will commence on October 15, 2025 through December 31, 2025 with the same terms and conditions as outlined in the Bid specifications and proposal.

WHEREAS, the maximum contract amount is \$182,000.00

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners hereby awards a contract for Repairs to Drain Pipes in Oldmans Township in the County of Salem., subject to the review of the County Solicitor, to South State Inc. the cost of which will not exceed \$182,000.00 (One Hundred Eighty-Two Thousand and Zero Cents) for the duration of the contract.
2. The contract shall commence on October 15, 2025, and terminate on December 31, 2025. This shall be completed in full accordance with the terms and conditions of the contract.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
