



RESOLUTION AWARDING COMPETITIVE CONTRACT FOR PROVIDING IN-SCHOOL YOUTH CAREER PATHWAYS PROGRAM SERVICES IN CUMBERLAND, SALEM AND CAPE MAY COUNTY BY MEANS OF THE CUMBERLAND SALEM CAPE MAY WORKFORCE DEVELOPMENT BOARD, RFP #26-08

WHEREAS, Salem County assisted the Cumberland, Salem, Cape May Workforce Development board in procuring In-School Youth Career Pathways Program Services in Cumberland County; and

WHEREAS, N.J.S.A. 40A:11-4.1 provides that a local contracting unit may use competitive contracting in lieu of public bidding for procurement of specialized goods and services, the price of which exceeds the bid threshold, for certain purposes including the aforementioned; and

WHEREAS, pursuant to N.J.S.A. 40A:11-4.3(a), this Board duly passed a resolution authorizing the use of competitive contracting for the provision of said services; and

WHEREAS, the Salem County Purchasing Agent as authorized contracting Agent for the Board of County Commissioners of the County of Salem requested, received and opened sealed proposals on May 6, 2026 at 11:00 AM prevailing time for Providing In-School Youth Career Pathways in Cumberland, Salem and Cape May County; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all proposal results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400, in the County of Salem, New Jersey, and

WHEREAS, vendors who submitted proposals for Providing In-School Youth Career Pathway Program Services in Cumberland, Salem and Cape May County by Means of the Cumberland Salem Cape May Workforce Development Board are as follows:

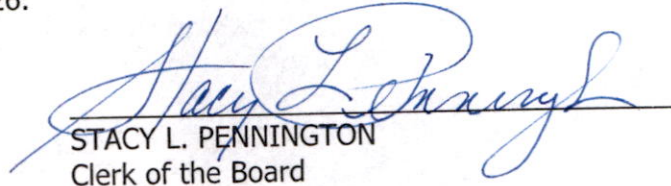
Cumberland County Division of Employment & Training \$255,000.00; and

WHEREAS, it has been determined that the Cumberland County Division of Employment & Training has substantially met necessary qualifications for the fulfillment of this contract; and further has provided the documentation necessary to successfully fulfill the requirement of the Cumberland Salem Cape May Workforce Development Board.

NOW THEREFORE, BE IT RESOLVED; by the Salem County Board of County Commissioners as follows:

1. That a contract pursuant to competitive contracting in lieu of competitive bidding is hereby awarded to Cumberland County Division of Employment & Training, 3322 College Drive, Vineland NJ 08360 in the amount not to exceed \$255,000.00 (Two Hundred Fifty-Five Thousand Dollars).
2. The contract shall commence on July 1, 2026, and will continue through June 30, 2027, with three (3) one (1) year renewals. This shall be completed in full accordance with the terms and conditions of the contract.
3. That the Director and Clerk of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.
4. That the Fiscal Agent (County of Cumberland) of the Regional Workforce Development Board shall be responsible for the payment and certification of all funds related to these programs.
